Product Description: Article Galaxy and Article Galaxy Scholar (AGS) are scientific content access platforms that enable researchers, librarians, and institutions to search for, request, and obtain full-text scientific articles and literature. The platforms support article ordering, document delivery, rights management, and access to millions of scientific publications from publishers worldwide. Both products are delivered as web applications accessible via browser.

Notes: Article Galaxy and Article Galaxy Scholar (AGS) have achieved conformance with WCAG 2.2 Level AA for their primary web platforms.

This report reflects evaluation via automated accessibility scanning by UserWay across Article Galaxy (reprintsdesk.com) conducted in April 2026 (scan date: 16-Apr-2026; issues first identified: 07-Apr-2026).

Five violations were identified across the scanned pages; all have been remediated via UserWay's Pro Widget, which provides equivalent facilitation for assistive technology users. This report covers WCAG 2.2 Level A and Level AA and applies to Article Galaxy and Article Galaxy Scholar. We welcome feedback at customersupport@researchsolutions.com.

Evaluation Methods Used: Automated accessibility scanning performed by UserWay across Article Galaxy and Article Galaxy Scholar in April 2026, evaluating pages across the product including authentication and login pages. Violations were assessed by WCAG criteria, severity (High, Medium, Low), and remediation status at time of export. All five identified violations were remediated via UserWay's Pro Widget prior to the publication of this report. The UserWay Pro Widget is deployed across Article Galaxy products and provides real-time accessibility remediation and equivalent facilitation for users of assistive technologies.
